



PUBLIC SAFETY UPDATE

The Village continues to work actively to address issues relating to public safety in our neighborhoods, our commercial districts and in our parks, beaches and recreational areas. On a daily basis our Code Enforcement Officers and Appearance Ticket Officers patrol all of these areas acting as our eyes and ears to protect our quality of life. Code Officers are empowered by law to issue appearance tickets to violators of the Village Code requiring them to appear in the Village Court, which has the power to impose fines of up to \$2,000 per offense, and in some cases jail sentences of up to 15 days. Our Village Court is extremely busy, meeting weekly to handle a large volume of cases. Attendance in our Court on Tuesday nights is "standing room only." To avoid the rush, persons wishing to plead guilty and pay a reduced fine can in most cases appear without appointment at the Court Office located on the second floor at Village Hall during normal business hours to pay their tickets.

During the course of their patrols, Code Officers assist the public in a number of other ways. Often they are the first ones at the scene of car accidents in the village and are able to assist with traffic control until the arrival of the police. Their presence in the commercial districts helps to keep the peace, especially at night, when patrons of our night spots occasionally become disorderly. Our Officers deal with minor instances of disorderly conduct by issuing appearance tickets, which often is enough to defuse a situation before it escalates out of control. In more serious situations involving actual violence, they radio for immediate police assistance, and provide backup for Suffolk County police officers when requested to do so. Code officers also patrol our residential neighborhoods on both the day and night shifts. If you are going away on a vacation or business trip and will be leaving your house unattended, Code will perform daily house checks at your request.

Due to their familiarity with the various areas of our Village and the people who frequent them, our Code Officers frequently provide useful intelligence to the police concerning potential criminal activity. Our Officers meet arriving Long Island Railroad trains, and they interact with homeless persons to provide them with assistance.

As Commissioner of Public Safety I work with Mayor Garant on ways to address the challenges which our Village faces as a result of the nationwide explosion in the use of heroin and other drugs. We meet regularly with the Suffolk County police to advocate for increased police presence and activity. To that end we also solicit and receive the support of other elected officials. Senator Ken LaValle and Legislator Kara Hahn have been strong advocates in this effort.

There is much more to do, and residents are stepping up to educate themselves and their neighbors about the impacts of crime and addiction in our Village. The recent formation of the Port Jefferson Community Alliance is a very promising sign that Port Jefferson residents want and expect more police presence and activity to address the problems we face. They have also partnered with our School District to educate the wider public about drug addiction among the student population. With the assistance of this group, the Village has instituted a Public Safety Committee to work with us on these concerns. The Committee held its first meeting on November 10 and will be holding its second meeting on Tuesday, December 1 at Village Hall. Meetings are open to the public. 

A Message from Mayor Margot Garant



*I*t's that time of year again to be thankful, share time with family and friends and to also remember our neighbors less fortunate and in need. The Board of Trustees and I just completed an Economic Impact study performed by Boston based Industrial Economics which calculates the loss of revenue and other detrimental economic impacts realized by the potential loss of tax dollars by a non operational power plant. I plan to deliver this report to our local and regional political partners and energy leaders advocating for a repowered plant and a stable tax environment for all of Suffolk county. The "ripple" affect from each reduced tax dollar could lead to reduced economic growth, loss of jobs, and compromised market values throughout the county. We do not stand alone in the face of the uncertain climate created by the unknown future of our power plant, so we are knocking on the important doors to make sure our town, county and state-wide partners understand these detrimental consequences.


